**1. Executive Summary**

This report is to inform the Executive Mayor of potential beneficiaries for the Site C1, Zwelihle IRDP housing project and for approval of the procedure to finalise subsidy applications for potential beneficiaries.

**6. Background/Discussion/Evaluation/Conclusion**

**Background**

A total number of 150 serviced sites had been developed in Zwelihle, known as Site C1 for potential beneficiaries who qualify in terms of the national criteria for IRDP. The serviced sites had originally been earmarked for potential beneficiaries in the income group R3 500,00 to R22 000,00.

Due to the high demand for low-income housing opportunities in Zwelihle, Council, on 28 November 2018, approved “*the proposal to develop 150 erven serviced under the Integrated Residential Development Programme (IRDP) in Site C1, Swartdam Road, Zwelihle, as BNG housing for those potential beneficiaries on the housing demand database*”. The Municipality subsequently submitted an application to the Provincial Department of Human Settlements for top structures to be built on the sites.

**Qualifying criteria for IRDP housing :**

Formal houses will be constructed for residents that qualify for housing subsidy in terms of the National Housing Code 2009 criteria namely:

- *Lawfully reside in South Africa (i.e citizen of the Republic of South Africa or in possession of a permanent residence permit). Certified copies of the relevant documents must be submitted with the application;*
- *Are legally competent to contract (i.e over 18 years of age or legally married or legally divorced or declared competent by a court of law and sound of mind);*
- *Neither the applicant nor his or her spouse has previously benefited from government housing assistance;*
- *Have not yet owned fixed residential property; and*
- *Have previously owned fixed residential property but such a person may only qualify for the purchase of a vacant serviced site.*

In addition to the above, the following criteria must also be satisfied:

- *Persons must be married or habitually cohabit;*
- *Single persons must be financial dependants;*
- *Single aged person, disabled persons and military veterans without financial dependant may be assisted. Aged persons refer to, must comply with the criteria on the aged as defined by the Department of Social Development;*
- *Households must earn a monthly income in the range as annually approved; and*
- *Persons who have benefited from the Land Restitution programme and who satisfy all other relevant criteria may also be assisted.*

In terms of Provincial Circular 10/2015, as amended, the following criterion must also be satisfied:

*An applicant must be registered on the housing demand database for a minimum period of three (3) years.*

**Relevant definitions**

**Farm residents:** Person whose ordinary residence is a farm, including a farm worker with ordinary residence on the Farm.

**Permanent disability**

The following characteristics apply to households affected by **permanent disability**:

A household with at least:

- one adult member (in the core household) having a permanent disability or
- a financial dependant with a permanent disability.

**Selection of beneficiaries**

**Potential beneficiaries**

The selection of potential beneficiaries will be done in the following order:

- *The application of the 90/10 rule with regard to the catchment area (project town) and the surrounding areas;*
- *selection according to the registration date of the households;*
- *selection of households containing an adult member of 60 years and older (quota 15%);*
- *selection of households who are affected by disabilities(quota 5%);*
- *selection of households according to registration as a farmworker (quota 5%).*

**The application of the 90/10% rule**

The following criteria, based on the Housing Selection Policy for Beneficiaries in BNG Subsidy Project, approved by Council on 29 April 2015, will apply for the project.( refer to Table1):

- housing opportunities reserved for potential beneficiaries that reside in the catchment area (Zwelihle) of the development; = 90%
  - housing opportunities reserved for potential beneficiaries across the other catchment areas of the Municipality. = 10%

It is recommended that the 10% of potential beneficiaries be selected from the housing demand database for Mount Pleasant. In 2016 a number of 65 housing opportunities of the 131 housing units build in Mount Pleasant were allocated to potential beneficiaries from the housing demand database of Zwelihle. The lastmentioned was an agreement by Councillors and the local communities.

An excess number of 22 beneficiaries for the Mount Pleasant housing development were approved by the Department of Human Settlements, Western Cape (DOHS) in 2016. Two (2) of the mentioned beneficiaries were subsequently approved by DOHS for the 22 serviced sites under the Finance Linked Individual Subsidy Programme (FLISP) in Mount Pleasant. It is therefore further recommended that preference be given to the mentioned excess number of 20 beneficiaries.

### **Quotas**

According to the Housing Selection Policy for beneficiaries in Ownership-based Subsidy Project the following quotas will apply to this project and will be spread across the 135 available housing opportunities (90% and 10% split):

Quota residents including farm workers	= 5%
Quota for households containing adults of 60 years and more in the core of the household.	= 15%
Quota for households affected by disabilities	= 5%

**Beneficiaries including the reserved quotas:**

A total percentage of 25% represents the reserved quotas, whilst the balance represents the 75% of beneficiaries and which is spread between the catchment and the surrounding areas, including farm workers resident in ward 4.

**Public Participation**

The local Ward Committees in Zwelihle were informed in November 2020 that funding has been approved to build 150 housing units and that the potential beneficiary selection will commence. An advertisement was placed in the local newspaper on 30 November 2020. Representatives from Department of Housing Administration were placed at the Zwelihle Community Hall from 30 November 2020 to 08 January 2021 (Monday to Friday) for the public to view the housing demand database and report any concerns.

The draft Council item with regard to potential beneficiaries was discussed with the Zwelihle local Councillors and Ward Committee members at a special meeting held on 26 January 2021. The last-mentioned participants of the meeting was satisfied with the list of potential beneficiaries. They also supported that the 10% of potential beneficiaries from surrounding areas outside the catchment (Zwelihle) be selected from the applications from the housing demand database from Mount Pleasant.

**Invitation to participate in the housing project in Zwelihle for potential beneficiaries resident outside the catchment area.**

A total of 15 invitations, which represent the 10% of the participants in the surrounding areas had been issued, of which three (3) responded positively. The remaining opportunities (those that declined = 12) will revert to the list of potential beneficiaries of Zwelihle.

**Processing of applications**

Potential beneficiaries will be formally invited to complete subsidy application forms. It is recommended that in the event of no response after the first written notice of 30 days, a second and final written notice of 7 days be issued. After successful notification by Council, the list of potential beneficiaries will be communicated to MCape Overstrand for the completion of subsidy applications of potential beneficiaries per the indicated ranking order.

**Approval by Provincial Department of Human Settlements**

After this report is noted by the Council, the lists of potential beneficiaries will be referred to the Provincial Department of Human Settlements for notification.

The closing date for public comments and objections was 18 December 2020. An item will be prepared to serve before Council and the construction of the project will commence during February 2021.
