The bid will not be considered and no further correspondence will be entered into with regard to the following matters:
  - 3.1.1 The tender has not been completed in non-erasable handwritten ink,
  - 3.1.2 Non-submission of a valid Tax Clearance Certificate and / or PIN,
  - 3.1.3 Incomplete Pricing Schedule or Bill of Quantities,
  - 3.1.4 A Form of Offer not signed in non-erasable ink,
  - 3.1.5 Bid submissions with material alterations / corrections not in compliance with Clause 1.2 and 1.3 above will be rejected.

- 1.2. The Overstrand will provide a RF Wireless backbone to facilitate the connectivity between the towns listed in 2.1 below and the Surveillance Operations Centre (Hermanus Fire Station).
- 1.3. The backbone's purpose is to build a surveillance system; connection bandwidth has been taken into account.
  - 1.3.1. The sites listed in 2.1 below will either be connected via peer-to-peer, or will be connected to a RF Wireless sector.
  - 1.3.2. Details of the backbone will be provided to the successful bidder.

### 2. SCOPE

- 2.1. The installation of fully equipped operational CCTV cameras and related equipment will be at the following locations:
