12. SPECIFICATIONS

1. INTRODUCTION / BACKGROUND

- 1.1 Overstrand Municipality is calling for formal quotations from prospective Service Providers to rent and maintain the required Parking Management System for the successful implementation of the Parking Management Services in the Hermanus Central Business District (CBD). This includes the provision of back office support and the generation of site daily reports. The duration of the service contract will commence from the date of signing of contract up until 30 June 2020.
- 1.2 The Overstrand Municipality is responsible for the allocation, maintenance and operation of public parking within its area of jurisdiction. Public parking is intended to assist the public in their daily business. Therefore the introduction of such a system will ensure controlled vehicle turnover and ease of doing business.
- 1.3 One of the most efficient ways to prevent long-term parkers from occupying available nearby parking, is to direct them to available parking space just outside the CBD and to enforce the by-law as approved by Council.

2. SCOPE

2.1 Handheld parking device system

- 2.1.1 The service provider must supply 20 handheld parking device systems with a portable printing facility.
