- 1.6. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

**2. DEFINITIONS**

- 2.1. **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.2. **“B-BBEE status level of contributor”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.3. **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.4. **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003) as amended by Act No 46 of 2013;
- 2.5. **“EME”** means an Exempted Micro Enterprise as defined by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6. **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents;
- 2.7. **“prices”** includes all applicable taxes less all unconditional discounts;

In terms of Section 37(2), read with section 41, of the said Act, it is legally possible for an employer to indemnify himself from this responsibility or liability regarding the actions of the mandatary. Section 37(2) stipulates that

## 11. SPECIFICATIONS

### 1. INTRODUCTION / BACKGROUND

Overstrand Municipality requires the services of a competent service provider to provide training to their Fire Dept. and the Environmental department. The training must make provision for the following:

- Training for officers and senior officials on planning and managing of a prescribe burn (±15 learners)
- Training for operational staff on how to conduct a prescribe burn (± 25 learners)

Overstrand Municipal jurisdiction is high fire risk and the municipality are in the process to develop a turn-around strategy and one of the strategies are to plan and conduct more prescribes burns. The training must cover all the legal responsibilities, biodiversity considerations, safe burning operations and a complete documented process from the planning stage to the conducting of the burn

### 2. SCOPE

Overstrand Municipality will provide the training venue for the theoretical training session. The catering for the training will be provided by the municipality. The service provider must provide all the training material and provide each student with a hand out. The Municipality will identify block which must be burned during the practical phase of the training. The municipality will apply for a burn permit and will take full accountability for the planned burn. Two separate courses will be presented during the theoretical phase, but the practical phase will be a combination of the two courses. This is to ensure that the management plan for the burn, are practical and the operational staff are capable of executing the burn plan. The plan burn will take place on municipal property, and the municipality is responsible to prep the blocks before the burn. The training will have a specific focus on planning and on practical execution of the burn plan. The training must adhere to all the Western Cape veld fire, ground teams and aerial firefighting work groups' norms and standards. The on-site incident management of the prescribe burn and the documentation of the burn must comply with Incident Command System (ICS), norms and standards as-well.

The training outcomes must cover the following critical cross field outcomes:

- Planning of prescribe burns, which include weather, veld age, topography, fire and non- fire conditions;
- Compiling a burn plan;
- Conducting and planning a burn prescribe burn, heap burn, back burn and fuel reduction burn;
- Using prescribe burn as a tool or tactic during active firefighting operations;
- Documentation of a prescribe burn; and
- Compliance with all the relevant legislation
