- 2.3. **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.4. **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003) as amended by Act No 46 of 2013;
- 2.5. **“EME”** means an Exempted Micro Enterprise as defined by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6. **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents;
- 2.7. **“prices”** includes all applicable taxes less all unconditional discounts;
- 2.8. **“proof of B-BBEE status level of contributor ”** means:

- 2.1 **Cut felled timber using a chainsaw and maintain chainsaw (Unit Standard 123233, NQF 2, Credits 4, Course duration 3 days)** - Training will take place in Hermanus (19 learners), Gansbaai (19 learners) and Kleinmond (8 learners). Hermanus and Gansbaai attendees will be divided into 2 groups and Kleinmond into 1 group.

#### 2.1.1 Candidates should understand the following aspects after completing this course:

##### Course Content:

- 2.1.1.1 External components of a chainsaw and their functions.
- 2.1.1.2 Component parts of a saw chain, chain dimensions, parts of a cutter, and chip removal.

##### Course Content:

- 2.2.1.1 Demonstrate an understanding of the effects of pruning and the reasons why this should be conducted.
- 2.2.1.2 The consequences of pruning, deliberate or incidental as described.
- 2.2.1.3 The conditions that necessitate pruning are described.
- 2.2.1.4 The role that pruning plays in the promotion of new growth and flowers is explained.
- 2.2.1.5 Select the appropriate tools for various pruning procedures.
- 2.2.1.6 The selection of the pruning tools most suitable for deadheading and removal of small stems and the reasons for selecting these tools are explained.
- 2.2.1.7 The selection of the pruning tools most suitable for cutting branches and hard stems and the reasons for selecting these tools are explained.

- 2.2.1.9 The factors that should be considered when rejecting pruning tools are described.

2.3 **Apply Herbicides to Noxious Weeds (Unit Standard 123134, NQF 1. Credits 3, Course duration 3 days) -** Training will take place in Hermanus (20 learners), Gansbaai (21 learners). Attendees will be divided into 2 groups per administration.

2.3.1 **Candidates should understand the following aspects after completing this course:**

**Course Content:**

- 2.3.1.1 The purpose of chemical weed control.
- 2.3.1.2 Inspecting equipment for serviceability and corrective action for specific procedures.
- 2.3.1.3 Chemical application techniques.
- 2.3.1.4 Safe working practices and procedures, the use of personal protective equipment, and hazard assessments.
- 2.3.1.5 Equipment calibration.
- 2.3.1.6 Symptoms and effects of agrochemical poisoning.
- 2.3.1.7 Action to take in the event of agrochemical poisoning.
- 2.3.1.8 Equipment cleaning and maintenance.

2.4 **Operate weedeater/brushcutter in the horticultural environment (Unit Standard 264182, NQF 2. Credits 4, Course duration 3 days) -** Training will take place in Hermanus (23 learners), Gansbaai (30 learners) and Kleinmond (20 learners). Attendees will be divided into 2 groups per administration.

2.4.1 **Candidates should understand the following aspects after completing this course:**

**Course Content:**

- 2.4.1.1 Apply the appropriate safety precautions when operating and maintaining a weedeater/brushcutter.
- 2.4.1.2 Select the appropriate attachments for trimming/cutting and prepare the work area.
- 2.4.1.3 Cut and trim using a weedeater/brushcutter.
- 2.4.1.4 Perform routine preventative maintenance on a weedeater/brushcutter.

#### 3.1. Training venue:
